Uranium Equities Limited (ASX: UEQ) advises that the Board has resolved, subject to all necessary shareholder and regulatory approvals, to issue a total of 5,281,405 fully paid ordinary shares to non-executive directors in satisfaction of unpaid directors' fees of \$104,572 as at 30 June 2013.

Payment of directors' fees has been suspended since 1 December 2012 as a cash conservation measure.

The amount of shares to be issued is based on a 30 day volume weighted average share price of 1.980 cents (up to and including 26 September 2013).

Approval of the share issue will be put to shareholders at the Company's next Annual General Meeting.
