### Completion of Capital Raising


DevEx Resources Ltd (**ASX:DEV or the Company**) is pleased to announce the successful completion of the \$5.5M placement previously announced on 8 July 2020.

The capital raising comprised of a two-tranche Placement with the first tranche being completed on 15 July 2020 raising approximately A\$4.7 million (before costs) through the issue of 47,590,767 fully paid ordinary shares to sophisticated and professional investors.

Tranche 2 was approved by shareholders at a general meeting of shareholders held on 3 September 2020 and a total of 8,100,000 fully paid ordinary shares have now been issued to the Directors of the Company or their nominees at an issue price of \$0.10 per share.
